

- 2) To assign PI and Sub-I, nurse etc. For respective trials.
- 3) To provide patients/ Subjects for the project will be responsibility of site.

Responsibility of CRNI:

- 1) To provide sufficient Staff/ CRC.
- 2) To conduct clinical trials according to International Conference of Harmonization for Good Clinical Practice guidelines and Documentations, as prescribed by NDCT Rule-2019, USFDA, EMEA and Japan Regulatory Authority.
- 3) Supervision for all projects from Presite selection visit to close out visit.
- 4) Confidentiality of Research Projects will be maintained by both the Parties.

Financial terms:

- 1) The financial term will be decided on project basis.
- 2) All investigations required for research purpose like Blood, X ray, ECG, ECHO, CT MRI, Angiography and, IPD, ICU charges, Room Charges will be borne by CRNI / Study sponsor.
- 3) All office expenses including stationary, printing, Xerox, scans, Telephone bills, International Fax and call bills, courier charges etc. will be paid by CRNI/ Study sponsor.

Non-Competition/Confidentiality
