1- Research Scientist-II, Post: 01

(i) Essential Qualifications

Post graduate degree (MD/MS/DNB) with 5 years R&D/teaching experience or postgraduate diploma in medical subjects with 6 years R&D /teaching experience in the required subject from recognized university;

MBBS recognized by MCI from any institute recognized by MCI or equivalent degree from a recognized University with 8 years R&D/Teaching experience in the relevant subject after MBBS degree;
