**INSTRUCTIONS FOR CANDIDATES REPORTING FOR ADMISSION INTO VARIOUS UG
PROGRAMS OF FACULTY OF ALLIED AND HEALTHCARE SCIENCES**

Candidates who have been allotted seats by Atal Bihari Vajpayee Medical University (ABVMU), Uttar Pradesh, for admission to various Undergraduate and Postgraduate programmes under the Faculty of Allied and Health Care Sciences are required to report to the College/Institute in person for completion of admission formalities.

All candidates are advised to carefully read and comply with the following instructions:

1. Admission shall be granted only to those candidates who have been allotted seats by ABVMU through the prescribed counselling process.
2. Candidates must report physically to the College/Institute on the date and time specified in the allotment letter issued by ABVMU.
3. At the time of reporting, candidates shall produce all original documents along with two sets of self-attested photocopies for verification.
4. The following documents are required at the time of admission:
 - a) Provisional Seat allotment letter
 - b) 5 Passport size color photograph with white background.
 - c) I Seat Confirmation Fee Deposit Receipt of INR 40,000/-
 - d) Photo ID proof (Aadhar card/Voter ID card/Driving license etc.) Verification sheet uploaded at the time of filling the application. Passing Certificate/Mark sheet/Statement of marks of 12th class (10+2)/equivalent examination from a recognized Board.
 - e) Certificate from the Board showing the Date of Birth. (Class 10th Passing Certificate)
 - f) 12th Class (10+2) Migration/Transfer Certificate.
 - g) Medical fitness certificate
 - h) The candidate should also bring the following certificate(s), if applicable:
 - i) SC/ST caste Certificate issued by the competent authority (Tehsildar/SDM) of Uttar Pradesh only.
 - j) Non creamy layer OBC/EWS Certificate issued by the competent authority issued on or after 1st April 2026. The OBC category should be mentioned in the List of OBC-NCL (Non-Creamy Layer) of Uttar Pradesh.
 - k) Persons with Benchmark Disability (PwBD) Certificate issued from a duly constituted and authorized Medical Board as mentioned in the Information Bulletin.
 - l) Dependent of Freedom Fighter certificate issued from District Magistrate.
 - m) Valid Ex-Servicemen certificate issued from competent authority.
 - n) Valid NCC certificate 'C' certificate with grade B issued by authorized battalion on prescribed format for NCC will be acceptable. **NCC 'A' and 'B' Certificates will not be considered for benefit of reservation under this category.**
 - o) Minority certificate (Christian/Jain/Muslim) where applicable for minority institutions.
5. Candidates having a gap in their academic studies shall submit a duly notarized Gap Certificate/Affidavit clearly indicating the period and reason for the gap.
6. Every candidate shall submit an Anti-Ragging Affidavit, duly signed by the student and parent/guardian, in the prescribed format at the time of admission.
7. Candidates shall submit a Medical Fitness Certificate issued by a Government Medical Officer/Registered Government Hospital certifying that the candidate is medically fit to pursue the course.
8. Admission shall remain provisional until verification of all original documents and confirmation by the Competent Authority.
9. In case any information furnished by the candidate is found to be false or any required document is not submitted, the admission shall be cancelled without prior notice.
10. Candidates are advised to retain copies of all documents and fee receipts submitted to the College/Institute for future reference.

11. Students admitted to the Faculty of Allied and Health Care Sciences, UPUMS shall abide by all rules, regulations, code of conduct, and anti-ragging guidelines of the University.

Failure to report for admission within the stipulated period prescribed by ABVMU shall result in forfeiture of the allotted seat, and the College/Institute shall not be responsible for any claim thereafter.
