With reference to your letter No.1352/E/UPUMS/Corr-UGC/2017-18 dated - 01.07.2017 on the subject cited above, I am directed to say that Uttar Pradesh University of Medicai &ciences, Saifai, Etawah - 206 130, Uttar Pradesh has been established by an Act No.15 of 2016 of State Legislature of Uttar Pradesh as a State University vide Notification No.742(2)/LXXIX-V-1-16-1(ka)-7-2015 dated - 17.05.2016 and is empowered to award degrees as specified by the UGC under section. 22 of the UGC Act 1956 through its own departments, its constituent colleges and/or through its affiliated colleges in regular mode with the approval of concerned statutory bodies/councils, wherever required.

The University is not allowed to start any off-campus centre beyond the territorial jurisdiction of the State as per Hon'ble Supreme Court Judgment in Prof. YashPal vs State of Chhattisgarh case.

The University may note and adhere to the following: -

- (i) To ensure that no off campus centre(s)/study centre and the centres operating through franchises is opened by the University outside the territorial jurisdiction of the State in view of the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal vs. Government of Chhattisgarh.
- (ii) In case the university has already started any off-campus/study centre and the centre operating through franchises outside the State, it must be closed immediately
- (iii) No distance education programmes shall be started without the prior approval of UGC.

- (iv) M.Phil/ Ph.D programmes can be conducted as per the provisions of UGC (Minimum Standards and Procedure for Awards of M.Phil/ Ph.D. Degree) Regulations, 2009.
- (v) The University is required to follow all the UGC Regulations notified and available on UGC website www.ugc.ac.in.
